

Once a Life Scout passes his Eagle Scout Board of Review, the boy is an Eagle Scout. Sometime between the Board of Review and Court of Honor (better sooner than later) letters should be mailed that request a congratulatory letter or certificate.

This list contains the names and addresses of prominent U.S. leaders or groups who will usually send letters or certificates of congratulations to new Eagle Scouts. Be sure to send a request to your State Representative or Assemblyman, U.S. Congressman, U.S. Senators, Mayor, City Council, County leaders, etc. This list is not all inclusive. A sample request letter is included at the end of the list. All request letters should be signed by the Scoutmaster.

Once congratulatory letters/certificates are received, they should be collected in a three-ring binder and displayed at the Eagle Court of Honor. Select letters may be read during the Eagle Court of Honor Ceremony. The letters make a wonderful keepsake.
